### ATTORNEY'S FEE PROVISION

Buyer further agrees to pay court costs.

### INTEREST CLAUSE

7. Interest shall be charged and added on to all open accounts at the rate of 15% per annum, or 1.25% per month, on the first day of any month following receipt of a statement.
